11) North 87 degrees 32 minutes 34 seconds West 122.54 feet to a point;
12 said point being the South West Corner of Lot number 22 of Earich's Walnut Hills Audition, passing the Southcast Corner of said Lot number 22 at 40.16 feet; thence leaving the said center of Township Road 474 North 00 degrees 30 minutes 00 seconds West 510.25 feet along the line of the said Lot number 22 to the place of beginning.

Containing 4.101 more or less acres (total) and 0.589 more or less acres being in Lot number 22. Subject to all legal road right-of-ways of Township Road number 474.
