LEGAL DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Springfield, and being part of the southeast quarter of Section 11, Township 16, Range 14, and being all of Lot #1 of an unrecorded subdivision known as the Burt Mule Farm Subdivision #1, and also being all those lands intended to be described in Deed Volume 534, page 674; being further bounded and described as follows:

Commencing at the northwest corner of the southeast quarter of said Section 11, thence, south 02 degrees - 32 minutes - 15 seconds west, 318.55 feet to a point; thence, south 86 degrees - 31 minutes - 45 seconds east, 528.09 feet to a point; thence, south 03 degrees - 11 minutes - 15 seconds west, 416.06 feet to an iron pin found, and the *true point of beginning* for the parcel herein intended to be described;

Thence, north 77 degrees - 31 minutes - 20 seconds east, 6.55 feet to a point;

Thence, south 12 degrees - 32 minutes - 55 seconds east, 269.36 feet to a point in the center of Coopermill Road, passing an iron pin set at 232.80 feet;

Thence, south 70 degrees - 59 minutes - 50 seconds west, 80.51 feet along said Coopermill Road to a point;

Thence, north 12 degrees - 32 minutes - 10 seconds west, 24.87 feet to an iron pin found;

Thence, continuing north 12 degrees - 32 minutes - 10 seconds west, 252.27 feet to an iron pin found;

Thence, north 76 degrees - 27 minutes - 10 seconds east, 73.40 feet to the *point of beginning*, and containing 0.502 acres more or less.

Bearings described herein are based on assumed azimuth and to be used for angle purposes only.

Iron pins set are 5/8" rebar with yellow identification cap (Finley S-7222).

Being all of Auditor's Parcel #62-31-01-21-000.




