

DESCRIPTION OF SURVEY FOR KROUS RENTALS

JOB#1769-1

Situated in the State of Ohio, County of Muskingum, Township of Springfield:

Being part of the Southeast Quarter, of Section 11, of Township 16, Range 14, of the Congress Lands East of the Scioto River, further being part of the Krous Rentals property recorded in Official Record Volume 2170, Page 734, of said county's deed records, further being part of Muskingum County Auditor's Parcel Number 62-31-03-21-000, and more particularly described as follows;

Commencing at an iron pin (found) at the common corner for Sections 11, 12, 13, & 14 of said Township and Range;

TIE-1 THENCE North 86 degrees 27 minutes 45 seconds West 208.11 feet along the common line for said Sections 11 and 14 to an iron pin (found) at a common corner for the Jo Clyde Armstrong and Andrew Armstrong property recorded in Official Record Volume 2085, Page 18 and for the Vicki Lovingshimer property recorded in Official Record Volume 1717, Page 184;

TIE-2 THENCE North 03 degrees 17 minutes 30 seconds East 410.30 feet into said Section 11 and along said Armstrong and Lovingshimer properties to an iron pin (found) at the Southeast corner of said Krous Rentals property;

TIE-3 THENCE North 81 degrees 41 minutes 10 seconds West 482.90 feet along said Krous and Armstrong properties to an iron pipe (found);

TIE-4 THENCE North 02 degrees 41 minutes 10 seconds East 982.55 feet continuing along said Krous and Armstrong properties to an iron pin (set) at the place of beginning for the property herein intended to be described, also being on the East right of way of Woody Lane (Township Road #1646);

#1- THENCE North 02 degrees 41 minutes 10 seconds East 10.00 feet continuing along said Krous and Armstrong properties and along said Woody Lane to an iron pin (set) at the Southwest corner of the Lepetomane XXI, Inc. property recorded in Official Record Volume 2132, Page 576;

#2- THENCE South 86 degrees 11 minutes 20 seconds East 491.58 feet leaving Woody Lane and along the common line for said Krous and Lepetomane properties to an iron pin (found) within the right of way for Benjamin Avenue (Township Road #1119), passing an iron pin (found) at 480.40 feet;

#3- THENCE South 03 degrees 17 minutes 30 seconds West 10.00 feet along the East line of said Krous property and within Benjamin Avenue to an iron pin (set);

#4- THENCE North 86 degrees 11 minutes 20 seconds West 491.47 feet leaving Benjamin Avenue and crossing said Krous property to the place of beginning, containing 0.11 acres.

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).

This parcel is not to be used as a separate building site or transferred as an independent parcel in the future without planning commission approval in accordance with applicable subdivision regulations. Parcel to be combined with adjacent Auditor's Parcel Number 62-31-03-23-000.




