AUDITORS PARCEL
#62-31-03-37-000 (ALL)

Situated in the Southeast quarter of section #11, T-16, R-14, Springfield Township, Muskingum County, Ohio. Being the lands conveyed to Gregory and Margaret Ritterbeck in Deed Book 753 page 212 of the Muakingum County deed records and being described as follows:

Beginning at the intersection of the centerline of Woody lane and the Southline of County Road #71 (Coopermill road);

- thence, S.04°52'38"W. a distance of 219.30 feet along the centerline of Woody Lane to a point on the North side of Chap's Run;
- thence, N.78°44'01"E. a distance of 34.26 feet along the Northwesterly bank of Chap's Run to a set iron pipe, passing a set iron pipe at 11.65 feet;
- thence, N.39°34'13"E. a distance of 86.83 feet along the Northwesterly bank of said run to a set iron pipe;
- thence, N.16°01'25"E. a distance of 85.25 feet along the Northwesterly bank of said run to a set iron pipe;
- thence, N.02°18'10"W. a distance of 82.17 feet along the Northwesterly bank of said run to a set iron pipe on the South line of C.R. #71 (Coopermill Road);
- thence, S.78°02'42"W. a distance of 92.51 feet along said South line to the point of beginning.

The above described parcel contains 0.420 acres, more or less, and is subject to all legal easements and right of wsys. All set iron pipes are 3/4" x 30" pipes with plastic I.D. caps. All set rebars are 5/8" x 30" rebars. North is based an assumed meridian.




