intended to be described; thence south 36 degrees 56 minutes 08 seconds
west along said centerline a distance of 110.24 feet to a point;
thence south 41 degrees 54 minutes 35 seconds west along said centerline
a distance of 91.71 feet to a point; thence south 43 degrees 51 minutes
35 seconds west along said centerline a distance of 132.01 feet to
a point; thence south 60 degrees 27 minutes 41 seconds west along
said centerline a distance of 342.49 feet to a point; thence south
