DESCRIPTION OF SURVEY FOR GREG WELKER 62-48-01-07

1500 Potts Ln

Situated in the State of Ohio, County of Muskingum, Township of Springfield, Northwest Quarter of Section #14, Township #14, Range #16, of the Congress Lands East of the Scioto River:

Being the remaining portion of prior deed reference Vol. 918, Page 279, of said County's records after subtracting a 3.712 acre tract surveyed from said prior deed reference, also being the remaining portion of Muskingum County Auditor's Parcel #62-62-48-01-07-000, and more particularly described as follows;

Commencing at a stone (found) at the Northeast corner of said Northwest Quarter of Section #14; thence (by deed) along the East line of said Northwest Quarter S 05° 00' 00" W 468.40 feet to an axle (found) at the Northeast corner of the property described in deed reference Vol. 559, Page 480, Parcel #2; thence continuing along said East line S 05° 00' 00" W 429.00 feet to the Southeast corner of said Vol. 559, Page 480, Parcel #2; thence along the South line of said Parcel #2 N 85° 00' 59" W 522.03 feet to an iron pin (set) at the place of beginning for the property herein intended to be described; thence S 03° 59' 08" E 116.65 feet to an iron pin (set); thence S 89° 51' 20" W 331.61 feet to the center of County Road #143 (Potts Lane), passing an iron pin (set) at 311.57 feet; thence along the center of said County Road N 03° 59' 08" W 146.66 feet; thence along the South line of said Vol. 559, Page 480, Parcel #2 S 85° 00' 59" E 334.96 feet to the place of beginning, passing an iron pin (set) 20.00 feet, containing 1.000 acres.






