DESCRIPTION OF SURVEY FOR CHARLES METCALF

Situated in the State of Ohio, County of Muskingum, Township of Springfield:

Being part of the Northeast Quarter, of Section #14, Township #16, Range #14, of the Congress Lands East of the Scioto River, **being all of** the Charles Metcalf property described in deed reference Deed Book Volume 883, Page 117 of said county's deed records, further known as Muskingum County **Auditor's Parcel Number 62-50-01-11-000**, and more particularly described as follows;

Beginning at an iron pin (set) at the Southeast corner of said Northeast Quarter of Section #14, also being the common corner for the Northeast corner of the Southeast Quarter of said Section #14 and the common Western corner for the Northwest and Southwest Quarters of Section #13 of said Township and Range;

- #1- **THENCE North 89 degrees 57 minutes 20 seconds West for a distance of 260.00 feet** along the common line for the Northeast and Southeast Quarters of Section #14 to an iron pin (set) at a common corner for said Metcalf property and for the T & B & W Thompson property recorded in deed reference Deed Book Volume 1120, Page 597;
- #2- **THENCE North 00 degrees 05 minutes 45 seconds West for a distance of 1354.53 feet** into said Northeast Quarter and along the West line of said Metcalf property and East line of said Thompson property and for the A & B Seevers property recorded in deed references Deed Book Volume 1139, Page 618 and Deed Book Volume 889, Page 197 to an iron pin (set) on the South line of the M Stine property recorded in deed reference Deed Book Volume 1123, Page 282, passing an iron pin (set) at 841.15 feet;
- #3- **THENCE South 89 degrees 54 minutes 40 seconds East for a distance of 256.85 feet** along the South line of said Stine property to an iron pin (found) at the Southeast corner of said Stine property and on the common line for said Sections #14 & #13;
- #4- **THENCE South 00 degrees 13 minutes 45 seconds East for a distance of 1354.34 feet** along the common line for said Sections #14 & #13 to the place of beginning, passing an iron pin (set) at 513.38 feet **containing 8.04 acres.**

The bearings within this description are based on a previous survey completed by Charles R. Harkness PLS #6885 on the M Stine property completed on May 30, 1996. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).

This description was written by Charles R. 
