THENCE WITH THE SAID EAST LINE, NORTH 00 DEGREES 00 MINUTES 00 SECONDS WEST 837.69 FEET TO AN IRON PIN SET, PASSING EXISTING IRON PINS AT 41.74 FEET (3/4 INCH PIPE-BENT), 296.50 FEET (3/4 INCH PIPE), 365.73 FEET (5/8 INCH REBAR), 618.66 FEET (3/4 INCH PIPE) AND 824.37 FEET (3/4 INCH PIPE);


