COMMENCING AT THE SOUTHEAST CORNER OF THE SOUTHWEST QUARTER OF SAID SECTION 14, THENCE, NORTH 90 DEGREES - 00 MINUTES - 00 SECONDS WEST, 716.10 FEET TO A POINT; THENCE, NORTH 06 DEGREES - 05 MINUTES - 00 SECONDS EAST, 299.35 FEET TO AN AXLE FOUND, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, NORTH 83 DEGREES - 29 MINUTES - 56 SECONDS WEST, 745.57 FEET TO A POINT IN POTTS LANE, PASSING IRON PINS FOUND AT 175.06 FEET, 349.92 FEET, AND 715.19 FEET; THENCE, ALONG SAID ROAD, NORTH 15 DEGREES - 41 MINUTES - 56 SECONDS EAST, 254.72 FEET TO A POINT; THENCE, LEAVING SAID ROAD, SOUTH 83 DEGREES - 26 MINUTES - 00 SECONDS EAST, 703.03 FEET TO AN AXLE FOUND, PASSING AN AXLE FOUND AT 31.60 FEET; THENCE, SOUTH 06 DEGREES - 05 MINUTES - 00 SECONDS WEST, 250.65 FEET TO THE POINT OF BEGINNING, PASSING AN AXLE FOUND AT 150.37 FEET, AND CONTAINING 4.1744 ACRES MORE OR LESS.


