Commencing at an iron pin (found) at the common corner for the Northeast and Northwest Quarters of said Section 6;

- TIE- THENCE South 03 degrees 44 minutes 55 seconds West 1133.78 feet along the common line for said Northeast and Northwest Quarters and common line for the Gary Blaine Smith and Roxy Rae Smith property recorded in Official Record Volume 2699, Page 901, the Rena Lillian Tracy property recorded in Official Record Volume 1841, Page 942, and said Ault property to an iron pin (set) at the place of beginning for the property herein intended to be described, passing the unmarked centerline of Wilkins Road as located prior to 1961 at 49.24 feet the current centerline of Wilkins Road at 80.34 feet, and iron pins (set) at 133.68 feet and 822.02 feet;
