DEED DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Springfield, T-15, R-14, being a resurvey of Kenneth E. & Barbara King Vol. 529 Pg. 982, being part of the Northwest Quarter of Section 2, and more particularly described as follows:

Beginning at an iron pin found (by deed) at the Southwest Corner of the Northwest Quarter of Section 2; thence along the West Line of Section 2 North 00 Degrees 00 Minutes 00 Seconds West 1213.71 feet to an iron pin found and the place of beginning; thence along the West Line of Section 2 North 00 Degrees 06 Minutes 43 Seconds East 294.32 feet to an iron pin set, passing the centerline of Twp. Rd. 669 (Luby Lane) at 33.21; thence South 89 Degrees 47 Minutes 34 Seconds East 192.99 feet to an iron pin found; thence South 00 Degrees 44 Minutes 11 Seconds West 99.88 feet to an iron pin set; thence South 77 Degrees 15 Minutes 47 Seconds East 186.85 feet to a point in the centerline of Co. Rd. 143 (Potts Lane), passing an iron pin set at 156.72 feet; thence along said centerline South 01 Degrees 58 Minutes 33 Seconds West 156.42 feet to a point; thence leaving said centerline along Luby Lane North 89 Degrees 24 Minutes 55 Seconds West 369.16 feet to the place of beginning, containing 2.03 acres, more or less, subject to all legal highways and easements.

Iron pins set are 5/8 inch rebar with plastic identification caps.

Bearings are based on the West Line of Section 2 as being North 00 Degrees 06 Minutes 43 Seconds East.

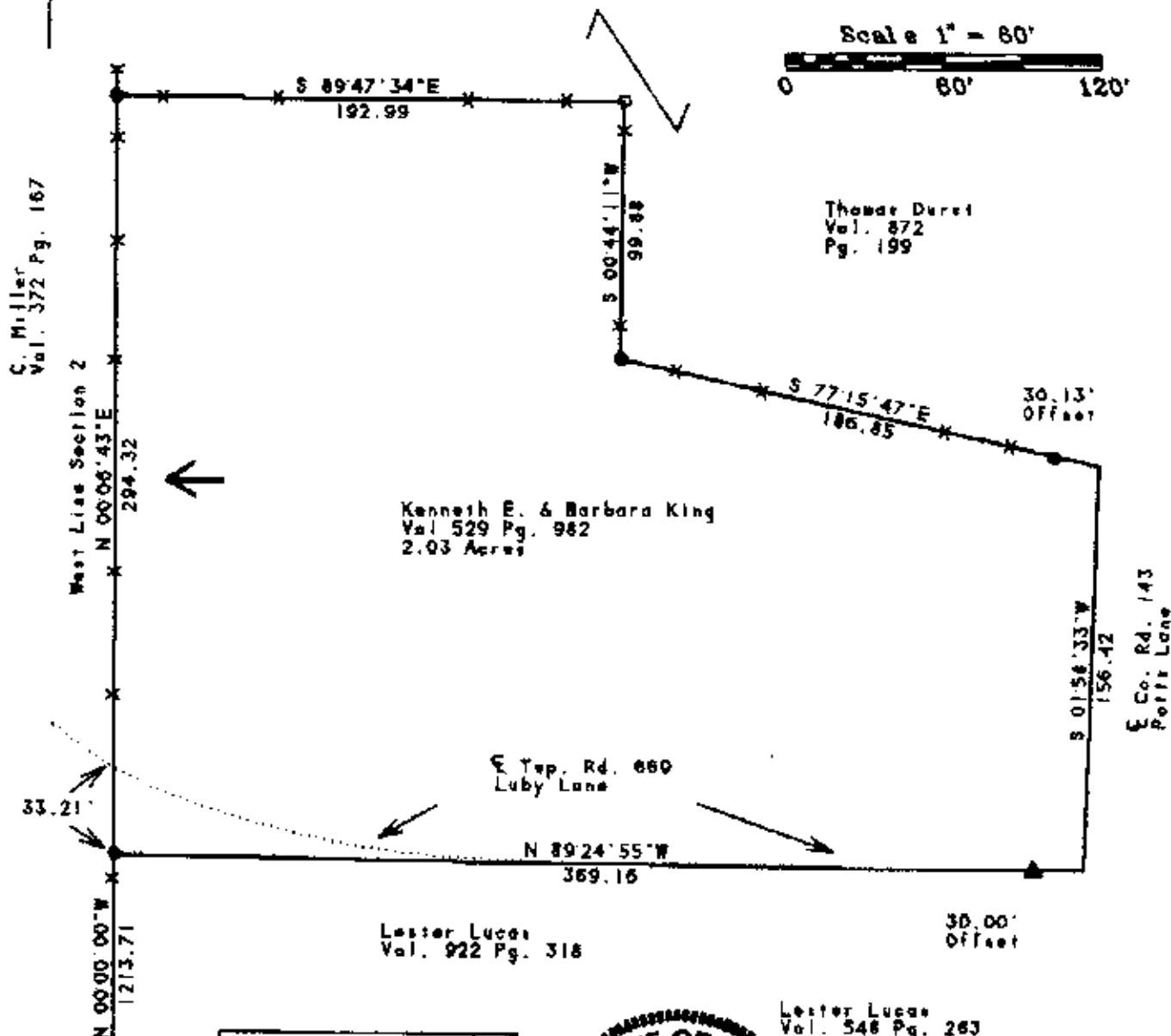
