## DEED DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Springfield, T-15, R-14, being a part of Thomas E & Bernice B. Durst Vol. 1563 Pg. 379, being part of the Northwest Quarter of Section 2, and more particularly described as follows:

Beginning at an iron pin found at the Southwest Corner of the Northwest Quarter of Section 2; thence along the West Line of Section 2 North 00 Degrees 06 Minutes 43 Seconds East 1213.71 feet to an iron pin found; thence South 89 Degrees 24 Minutes 48 Seconds East 165.87 feet to a point in Twp. Rd. 669 and the place of beginning; thence leaving said road North 07 Degrees 41 Minutes 55 Seconds East 168.18 feet to an iron pin set, passing an iron pin set at 29.21 feet; thence South 76 Degrees 25 Minutes 39 Seconds East 65.30 feet to an iron pin set; thence North 16 Degrees 19 Minutes 32 Seconds East 29.95 feet to an iron pin set; thence South 77 Degrees 15 Minutes 47 Seconds East 117.13 feet to a point in the centerline of Co. Rd. 143, passing an iron pin found at 87.00 feet; thence along said centerline South 01 Degrees 58 Minutes 33 Seconds West 156.42 feet to a point; thence along Twp. Rd. 669 North 89 Degrees 24 Minutes 55 Seconds West 203.29 feet to the place of beginning, passing an railroad spike found at 30.00 feet, containing 0.741 acres, more or less, subject to all legal highways and easements.





