Commencing at an iron pin found at the Northeast corner of Lot 44; Thence North $78^{\circ}23'22''$ West 47.50 feet to an iron pin set the place of beginning; Thence South $11^{\circ}28'51''$ West 162.93 feet to an iron pin set on the South line of Lot 44; Thence North $74^{\circ}17'13''$ West along the South line of Lot 44 and 45, 187.44 feet to an iron pin set passing an axle found at 52.58 feet at the corner of Lots 48 and 49 at 82.68 feet; Thence North $85^{\circ}56'33''$ West along Lot 46 10.00 feet to an iron pin set; Thence North $11^{\circ}13'53''$ East 150.84 feet to an axle found at the Northwest corner of Lot 45 (Northeast corner of Lot 46); Thence South $78^{\circ}23'22''$ East along Summit Drive 197.50 feet to the place of beginning containing 0.71 Acres more or less passing an axle found at the Northeast corner of Lot 45 at 125.00 feet.

Bearings are based on Springdale Subdivision No. 5, Plat Book 10, page 37 and 39.

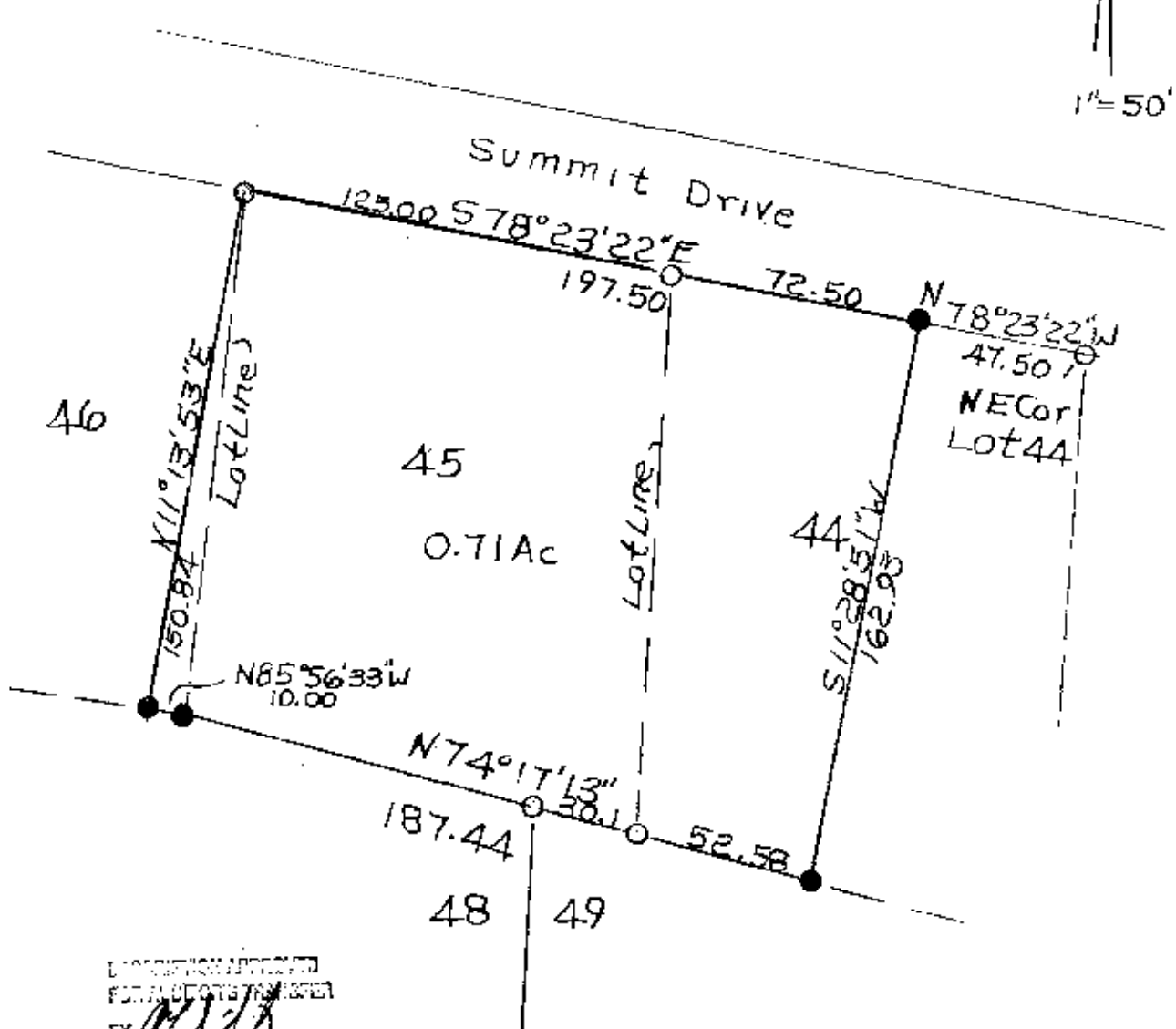
