SURVEY DESCRIPTION
FOR
TITLE FIRST

AUDITORS PARCEL
#62-70-06-30-000 (ALL)

Situated in the Northwest Quarter of section 2, T-15, R-14, Springfield Township, Muskingum County, Ohio. Being the lands of Charles and Margaret Fink as conveyed in Deed Book 708 page 306 of the Muskingum County deed records and being described as follows:

Beginning at the Southeast corner of lot #62 of Springdale Addition #5 as recorded in Plat Book 10 page 39 of the Muskingum County Plat records;

thence, S.00°45'00"W. a distance of 630.96 feet along the west side of the lands now or formerly, owned by D. Hina, Et Al, (1070/307), passing a stone found at 12.11 feet, and a set rebar at 595.96 feet, to a point on the South line of Springfield Township;

thence, N.89°59'53"W. a distance of 91.27 feet along the south line of said township to a point, being the Southeast corner of the lands, now or formerly, owned by C. Paxson (1033/396);

thence, N.00°45'00"E. a distance of 658.09 feet along said Paxson lands to a point on the South line of lot 62 of Springdale Add. #5, passing a found iron pipe at 33.57 feet and a set rebar at 608.09 feet;

thence, S.73°23'00"E. a distance of 94.88 feet along said lot line to the point of beginning.

The above described parcel contains 1.350 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars. North is based an assumed meridian.

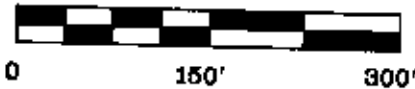
