Also the right to use the exist 25.00 foot right of way for access to Bradford Court Drive.

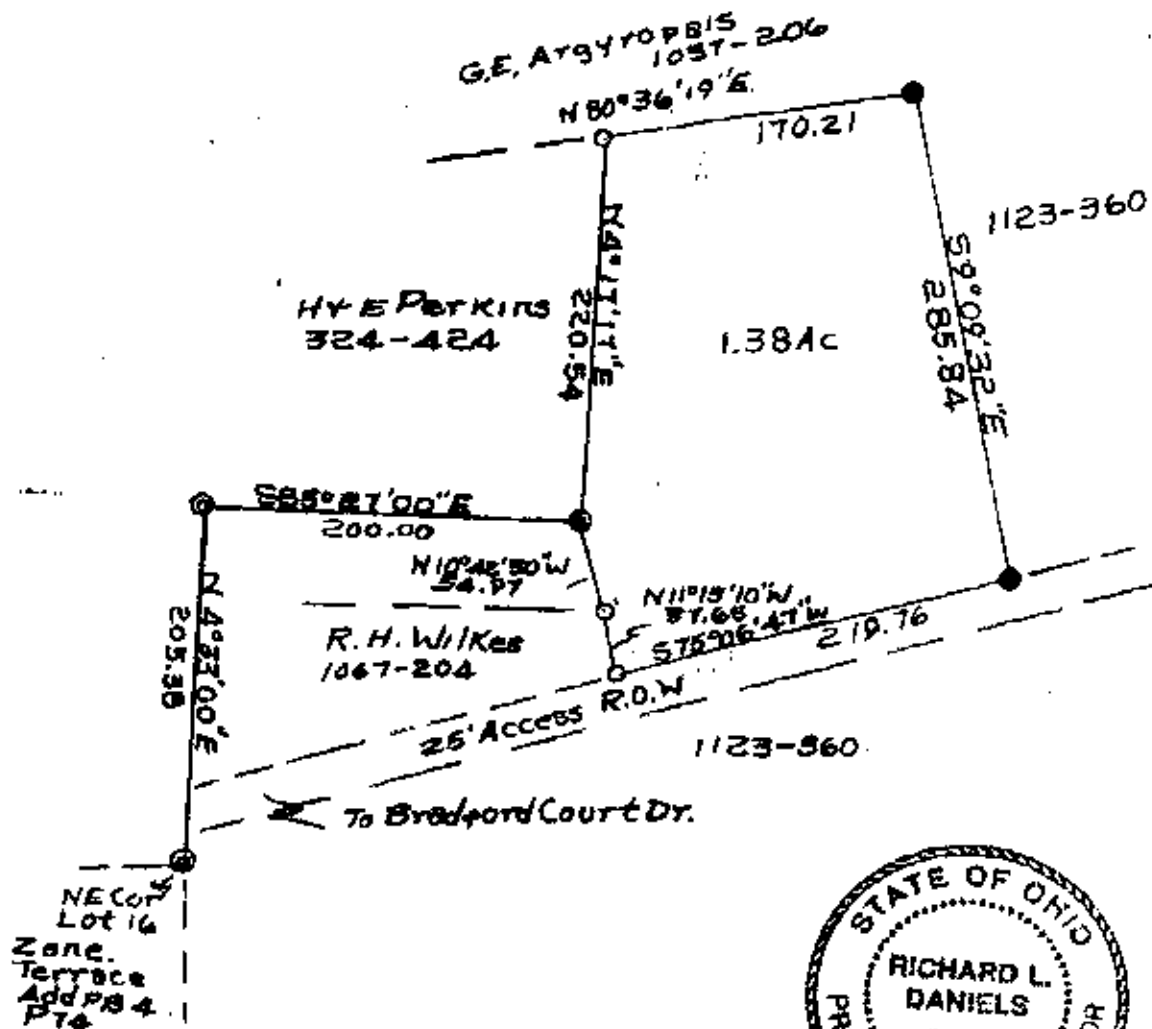
Iron pins set are number 5 reinf. bars 30 inches long with plastic ID caps.
