

DESCRIPTION OF SURVEY FOR HAROLD AND ALICE LePAGE JOB#1443

Situated in the State of Ohio, County of Muskingum, Township of Springfield:

Being part of the Northeast Quarter, of Section #1, Township #15, Range #14, of the Congress Lands East of the Scioto River, being all of the Harold and Alice LePage property recorded in Deed Book Volume 517, Page 512 of said county's deed records, further being known as Muskingum County Auditor's Parcel Number 62-76-02-03-000, and more particularly described as follows;

Commencing at a stone (found) marked at the common corner for said Section #1 and for Section #5 of Township #11, Range #13 and for Section #15 of Township #12, Range #13, and for Section #13, of Township #16, Range #14; THENCE North 85 degrees 06 minutes 30 seconds West 191.42 feet along the common line for said Sections #1 & #13 also along the Corporation line for the Village of South Zanesville, to an axle (found) at a common corner for said LePage property and for the E Shafer property recorded in Deed Book Volume 518, Page 648, also being the place of beginning for the property herein intended to be described;

- #1- THENCE South 01 degrees 54 minutes 05 seconds West 213.44 feet into said Section #1 and along the common line for said LePage and Shafer properties to an axle (found) on the North right of way of Grandview Street;
- #2- THENCE along a curve to the left having, a chord bearing South 63 degrees 20 minutes 50 seconds West 6.15 feet, a radius of 208.57 feet, and arc length of 6.15 feet along said North right of way to an axle (found);
- #3- THENCE South 62 degrees 10 minutes 50 seconds West 122.07 feet continuing along said North right of way to an iron pin (set) in the roadbed of said Grandview Street;
- #4- THENCE North 89 degrees 21 minutes 10 seconds West 60.45 feet along the North right of way for said Grandview Street and for Sally Drive to an axle (found);
- #5- THENCE North 00 degrees 38 minutes 50 seconds East 287.59 feet along the East right of way for said Sally Drive to an axle (found) on the common line for said Sections #1 and #13;
- #6- THENCE South 85 degrees 06 minutes 30 seconds East 178.38 feet along said Section Line to the place of beginning, containing 1.05 acres.

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).


