THENCE SOUTH 42 DEGREES 51 MINUTES EAST 57.28 FEET (BY DEED) TO A POINT;

THENCE SOUTH 71 DEGREES 24 MINUTES EAST 186.40 FEET (BY DEED) TO A POINT;

THENCE NORTH 20 DEGREES 07 MINUTES EAST 118.44 FEET (BY DEED) TO A POINT;

THENCE NORTH 31 DEGREES 10 MINUTES EAST 212.31 FEET (BY DEED) TO A POINT;

THENCE SOUTH 13 DEGREES 58 MINUTES 00 SECONDS WEST 21.68 FEET (BY DEED) TO A POINT IN THE CENTER OF COUNTY ROAD 6;

THENCE NORTH 81 DEGREES 15 MINUTES 00 SECONDS EAST 76.53 FEET ALONG THE SOUTH LINE OF A 2.13 ACRE TRACT AS RECORDED IN DEED BOOK 577, PAGE 472 OF THE MUSKINGUM COUNTY DEED RECORDS, TO A POINT IN THE CENTER OF THE SAID COUNTY ROAD, SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE WITH THE EAST LINE OF A TRACT CONVEYED TO A. & K. SEALOVER BY DEED RECORDED IN VOLUME 1003, PAGE 33 AND THE EAST LINE OF A TRACT CONVEYED TO F. & W. HETTICH BY DEED RECORDED IN VOLUME 964, PAGE 37 OF THE MUSKINGUM COUNTY DEED RECORDS, NORTH 06 DEGREES 25 MINUTES 15 SECONDS EAST, PASSING AN EXISTING IRON PIN (AXLE) AT 20.73 FEET, A TOTAL DISTANCE OF 250.64 FEET TO AN EXISTING IRON PIN (AXLE), SAID EXISTING IRON PIN BEING SOUTH 06 DEGREES 25 MINUTES 15 SECONDS WEST 357.30 FEET FROM AN EXISTING IRON PIN (1" PIPE);




