Thence along the section line, South 02 degrees 50 minutes 51 seconds West, 163.80 feet to a point in the centerline of Grantcliff Road, (Twp. Rd. 467);

Thence along the centerline of said road, the following four courses:

- 1.) North 79 degrees 47 minutes 37 seconds East, 172.01 feet to a point;
- 2.) North 80 degrees 22 minutes 30 seconds East, 206.22 feet to a point;
- 3.) North 81 degrees 21 minutes 04 seconds East, 215.60 feet to a point;
- 4.) North 82 degrees 10 minutes 47 seconds East, 204.01 feet to a point on the northwest corner of lands presently owned by Randolf Clint Robert Neff, (OR 2466-385), and the northeast corner of lands presently owned by Donald L. and Frances C. Holdren, (DR 1139-891);

Thence along the west line of said Randolf Neff lands, and the east line of said Holdren lands, South 09 degrees 20 minutes 54 seconds East, 255.62 feet to an iron pin set, passing an iron pin found at 22.86 feet, and being the principal place of beginning;

Thence through the lands of said Randolf Clint Robert Neff lands, South 83 degrees 14 minutes 46 seconds East, 191.81 feet to an iron pin set on a corner of lands presently owned by Neff Investments Ltd. of Ohio, (OR 2930-277);

Thence along the north line of said Neff Investments lands, South 84 degrees 30 minutes 34 seconds West, 184.72 feet to an iron pin set on the southeast corner of lands presently owned by Donald L. and Frances C. Holdren, (DR 1139-891), passing an iron pin found at 164.61feet;

Thence along the east line of said Holdren lands North 09 degrees 19 minutes 40 seconds West, 40.77 feet to the principal place of beginning, containing 0.09 acres, more or less, and being part of Auditor's Parcel Numbers 62-82-01-01-002 +- 0.07 Acres, and 62-82-01-01-004 +- 0.02 Acres.
