Situated in the State of Ohio, County of Muskingum, Township of Springfield, Township 15 North, Range 13 West, Southwest Quarter of Section 5 and being further described as follows; Commencing at a point at the northwest corner of the Southwest Quarter of Section 5, thence South 05° 20' 00" West, 158.63 feet along the west line of Section 5 to a point on the centerline of Grantcliff Road - Township Road #467, thence, North 82° 36' 00" East, 330.79 feet to a point on the centerline of the said Grantcliff Road, thence, North 83° 51' 34" East, 479.43 feet to a point on the centerline of Grantcliff Road, thence, North 88° 09' 16" East, 7.11 feet to a point on the centerline of the said Grantcliff Road, said point being also the point of beginning of the parcel herein described,

thence, continuing North 88° 09' 16" East, 139.15 feet to a point on the centerline of the said Grantcliff Road,

thence, North 48° 48' 01" East, 31.08 feet along a north line of R. Neff (Deed Book 982, Page 415) to a point,

thence, South 07° 04' 19" East, 312.71 feet across the said R. Neff to a point at an iron pin - set - passing an iron pin - set - at 36.34 feet,

thence, South 86° 46' 58" West, 164.67 feet across the said R. Neff to a point at an iron pin - found - at the southeast corner of D. and F. Holdren (Deed Book 1065, Page 407),

thence, North 07° 04' 19" West, 296.88 feet along the east side of the said D. and F. Holdren to the point of beginning, passing an iron pin - found - at 274.~~88~~^{.88} feet, containing 1.118 acres more or less.


