Re-Survey of George G. and Hilda Pappas Lands in Union Township, Muskingum County

Situated in the State of Ohio, County of Muskingum, Township of Union, and being part of the Southeast Quarter of Section 5, Township 1, Range 5, United States Military Lands, and being all the lands presently owned by George G. and Hilda Pappas as per Official Record 1804, Page 921, and Deed Record 638, Page 24, and being more particularly described as follows:

Beginning for reference at a stone found on the northeast corner of the Southeast Quarter of Section 5, Township 1, Range 5, United States Military Lands;

Thence along the west line of William K. and Marilyn R. McKelvey, (DR 675-259), South 01 degrees 56 minutes 09 seconds West, 812.07 feet to an iron pin found, and being the principal place of beginning;

Thence continuing along the west line of said McKelvey lands, South 02 degrees 00 minutes 06 seconds West, 304.60 feet to an iron pin found in the centerline of Pidcock Road, (Twp. Rd. 440), and being the northwest corner of lands presently owned by Leo and Debra D. Buechner, (DR 1077-276);

Thence along the west line of said Buechner lands, the following two courses:

- 1.) South 04 degrees 08 minutes 13 seconds West, 30.08 feet to an iron pin found;
- 2.) South 03 degrees 44 minutes 26 seconds West, 521.78 feet to an iron pin found on the northeast corner of lands also owned by Leo and Debra D. Buechner, (DR 1077-276);

Thence along the north line of said Buechner lands, South 47 degrees 50 minutes 05 seconds West, 416.12 feet to an iron pin found on the northeast corner of lands also owned by Leo and Debra D. Buechner, (DR 1077-273);

Thence along the north line of said Buechner lands, South 47 degrees 50 minutes 47 seconds West, 478.40 feet to an iron pin found;

Thence along the west line of said Buechner lands, South 43 degrees 08 minutes 51 seconds East, 130.97 feet to an iron pin found in Norwich Valley Road, (Twp. Rd. 188), and being the most easterly corner of lands presently owned by Larry L. and Sandra J. Blackwood, DR 1148-632, and DR 576-932;

Thence along the lines of said Blackwood lands the following three courses:

- 1.) North 85 degrees 31 minutes 40 seconds West, 64.40 feet to a point in the road;
- 2.) North 78 degrees 42 minutes 13 seconds West, 45.88 feet to a point;
- 3.) North 78 degrees 48 minutes 09 seconds West, 57.86 feet to an iron pin set on the north line of said Blackwood lands;

Thence along the north line of said Blackwood lands, and also the north line of lands presently owned by Andrew H. and Marcie L. Blackwood, (OR 2258-663, DR 1148-259, and OR 2197-227), and James L. and Carolyn K. Blackwood, (DR 1143-789), South 47 degrees 22 minutes 07 seconds West, 846.18 feet to an iron pin found, on the northeast of lands presently owned by Gregory J. and Michael R. Connell, (DR 1071-572), and the section line, from which an iron pin found bears South 80 degrees 22 minutes 40 seconds East, 3.30 feet;

Thence along the section line, and the north line of said Connell lands, and the north line of lands presently owned by Mathew R. Connell, (OR 2591-862), North 87 degrees 37 minutes 13 seconds West, 1323.34 feet to an iron pipe found on the southeast corner of lands presently owned by Stephen and Cindy Burkhart, (OR 1973-167);
