BEING A PART OF NORTHWEST QUARTER OF SECTION 5, TOWNSHIP 1, RANGE 5, OF THE UNITED STATES MILITARY LANDS, UNION TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT AN EXISTING IRON PIN (3/4 INCH ROD) AT THE NORTHWEST CORNER OF THE NORTHWEST QUARTER OF SECTION 5; THENCE SOUTH 03 DEGREES 42 MINUTES 18 SECONDS WEST 850.94 FEET TO AN IRON PIN SET, PASSING IRON PINS SET AT 220.66 FEET, 455.18 FEET, AND 679.04 FEET;

THENCE WITH THE NORTH LINE OF A TRACT CONVEYED TO R.E. & W.E. CHANEY BY DEED RECORDED IN VOLUME 570, PAGE 384 OF THE MUSKINGUM COUNTY DEED RECORDS, SOUTH 86 DEGREES 25 MINUTES 51 SECONDS EAST 313.86 FEET TO AN EXISTING STONE;

THENCE SOUTH 03 DEGREES 42 MINUTES 31 SECONDS WEST ALONG THE EAST LINE OF THE SAID CHANEY TRACT 415.06 FEET TO AN IRON PIN SET, SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED, PASSING AN IRON PIN SET AT 101.43 FEET;

THENCE NORTH 78 DEGREES 56 MINUTES 27 SECONDS EAST 993.76 FEET TO A POINT IN THE CENTER OF FIDCOCK ROAD (TOWNSHIP ROAD 440), PASSING IRON PINS SET AT 662.88 FEET AND 963.76 FEET;

THENCE WITH THE SAID TOWNSHIP ROAD FOR THE NEXT SEVEN COURSES AND DISTANCES:

- 1) SOUTH 30 DEGREES 33 MINUTES 49 SECONDS EAST 51.25 FEET TO A POINT;
- 2) SOUTH 22 DEGREES 21 MINUTES 29 SECONDS EAST 50.12 FEET TO A POINT;
- 3) SOUTH 16 DEGREES 14 MINUTES 37 SECONDS EAST 52.63 FEET TO A POINT;
- 4) SOUTH 09 DEGREES 25 MINUTES 16 SECONDS EAST 145.56 FEET TO A POINT;
- 5) SOUTH 13 DEGREES 56 MINUTES 31 SECONDS EAST 36.79 FEET TO A POINT;
- 6) SOUTH 21 DEGREES 26 MINUTES 16 SECONDS EAST 35.85 FEET TO A POINT;
- 7) SOUTH 39 DEGREES 30 MINUTES 51 SECONDS EAST 65.53 TO AN EXISTING RAILROAD SPIKE;

THENCE LEAVING THE SAID ROAD AND WITH THE NORTH LINE OF THE 104.377 ACRE TRACT CONVEYED TO WAYNE DAILEY BY DEED RECORDED IN VOLUME 989, PAGE 384 OF THE SAID COUNTY RECORDS, NORTH 86 DEGREES 25 MINUTES 52 SECONDS WEST 1134.12 FEET TO AN IRON PIN SET AT THE SOUTHEAST CORNER OF THE ABOVE SAID CHANEY TRACT, PASSING AN IRON PIN SET AT 50.00 FEET AND A EXISTING STONE AT 91.93 FEET;

THENCE, NORTH 03 DEGREES 42 MINUTES 31 SECONDS EAST, WITH THE EAST LINE OF THE SAID CHANEY TRACT 143.30 FEET TO THE PLACE OF BEGINNING.




