Tract One

Situated in the State of Ohio, County of Muskingum, Township of Union and being a part of the East Half of the Northeast Quarter of Section 6, T1, R5, United States Military Lands more particularly described as follows.

Beginning at an iron pin found at the northeast corner of said Section 6, thence with the east line of said Section 6, S02°19'52"W, a distance of 1255.21 feet to an iron pin found on the northeast corner of the lands now owned by Jerry M. & Laura L. Blackwood (OR 2016-232);

thence with the common line of said Blackwood/Blackwood's lands, S83°42'46"W, a distance of 421.36 feet to an iron pin found;

thence going through said James L. & Carolyn K. Blackwood's lands, N89°10'30"W, a distance of 906.20 feet to an iron pin set on the common line of the east half and west half of northeast quarter of said Section 6;

thence with the common line of said east half and west half of said northeast quarter, N02°17'56"E, a distance of 1343.39 feet to an iron pin set at the northwest corner of the east half of said northeast quarter, Section 6;

thence with the north line of said northeast quarter, S87°36'59"E, a distance of 1323.25 feet to the place of beginning, containing a total of 40.001 acres more or less, subject to all legal highways and easements of record.

All bearings described herein are based on the Ohio State Plane Grid Coordinates, NAD83, Ohio South per GPS Observation.

All iron pins set are 5/8 inch by 30 inch steel rebar with plastic identification caps marked MCPEEK PS8517.

The above described 40.001 acre parcel is based on a field survey made by McPeek Land Surveying on October 5th., 2018.

Tract Two

Situated in the State of Ohio, County of Muskingum, Township of Union and being a part of the East Half of the Northeast Quarter of Section 6 and the East Half of the Southeast Quarter of Section 6, T1, R5, United States Military Lands more particularly described as follows.

Beginning for reference at a stone found at the southwest corner of the east half of the southeast quarter of said Section 6, thence with the half quarter section line, N02°17'56"E, a distance of 2062.55 feet to a point in the center of a creek and the principal place of beginning;

thence continuing with said half quarter section line, N02°17'56"E, a distance of 581.87 feet to an iron pin set at the southwest corner of the east half of the northeast quarter of said Section 6, passing an iron pin set at 16.73 feet;

thence with the half quarter section line, now dividing the northeast quarter and northwest quarter of said Section 6, N02°17'56"E, a distance of 1301.04 feet to an iron pin set;

thence going through said James L. & Carolyn K. Blackwood's lands, S89°10'30"E, a distance of 906.20 feet to an iron pin found on the northwest corner of the lands now owned by Jerry M. & Laura L. Blackwood (OR 2016-232);

thence with the common line of said Blackwood/Blackwood's lands the following eleven courses (11):

7. with the center of said Blackwood lane on a curve to the left, having a radius of 93.28 feet, arc distance of 70.00 feet, chord bearing S67°11'44"E a distance of 68.37 feet to a point;
8. S88°41'38"E, a distance of 96.24 feet to a point;
9. N81°03'30"E, a distance of 207.58 feet to a point;
10. S73°24'17"E, a distance of 45.90 feet to a point;
11. S33°12'21"E, a distance of 71.47 feet to a point on the east line of said Section 6;

thence with the east line of said Section 6, S02°20'35"W, a distance of 134.54 feet to an iron pin found on the northeast corner of the lands now owned by Becky Coulter & Lorie Kirkman (OR 2435-114);

thence with the common line of said Blackwood/Coulter & Kirkman, S73°56'37"W, a distance of 219.72 feet to an iron pin found on the mid section line of said Section 6;

thence with said mid section line, N87°45'09"W, a distance of 43.21 feet to a point on the center of a creek, being the common line of the lands now owned by Bainridge LLC (OR 2210-67) and said Blackwood's lands;

thence leaving said mid-section line and going with the center of said creek the following ten (10) courses:

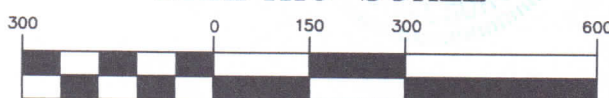
