Description For Conveyance Part of Parcel #66-01-06-15-000

Situated in the State of Ohio, County of Muskingum, Township of Union.

Being a part of the West Half of the Southeast Quarter of Section 6, Township 1, Range 5 bounded and described as follows:

Beginning at a stone found at the southeast corner of the west half of the southeast quarter of Section 6; thence along the south line of said quarter south 89 degrees 55 minutes 34 seconds west 346.68 feet to an iron pin (axle) found; thence north 8 degrees 23 minutes west 410.87 feet to a point in the center of U.S. Routes 22 and 40; thence along said centerline north 74 degrees 31 minutes east 417.92 feet to a point; thence leaving said centerline south 0 degrees 25 minutes 27 seconds east 517.61 feet to the place of beginning, containing four and two hundredths (4.02) acres more or less.

Subject to the easements of U.S. Routes 22 and 40 containing 0.89 acres.


