Description of Parcel 4

Situated in the State of Ohio, County of Muskingum, Township of Union, being in the Northwest quarter of Section 4, Range 5 West, Township 1 North, of "The United States Military District", and being bounded and described as follows:

Commencing for reference at an iron pin found capped "Spilker Surveying 5862" at the northwest corner of Section 4 (Note: Reference bearing on the north line of Section 4 used as South 85°29'44" East.);

thence, with the west line of Section 4, South 03°32'00" West a distance of 1,489.00 feet to an iron pin set, being THE TRUE POINT OF BEGINNING for this description;

thence, from said Point of Beginning leaving the section line, North 83°52'36" East a distance of 384.38 feet to an iron pin set;

thence South 06°07'24" East a distance of 200.00 feet to an iron pin set;

thence North 85°48'52" East a distance of 1,039.48 feet to a point in the centerline of County Road No. 21 (Lodge Road), passing through two iron pins set at distances of plus 917.78 feet and plus 1,017.78 feet, respectively;

thence, with the centerline of County Road No. 21, the following four courses:

- (1) South 23°04'51" East a distance of 111.33 feet to a railroad spike found;
- (2) thence South 29°43'10" East a distance of 100.00 feet to a point;
- (3) thence South 22°47'55" East a distance of 100.00 feet to a point;
- (4) thence South 02°22'49" East a distance of 100.00 feet to a point;

thence, leaving the road, South 81°54'18" West a distance 1,635.48 feet to an iron pin set in the west line of Section 4, passing through two iron pins set at distances of plus 30.00 feet and plus 130.00 feet, respectively;

thence, with the west line of Section 4, North 03°32'00" East a distance of ~~696.98~~ feet to the Point of Beginning;

Said easement is for the purposes of running utilities to other parcels of land on or near County Road No. 21. Said easement runs in a north-south direction across the east end of the above described property with the east line of said easement being the centerline of County Road No. 21. Containing 0.283 acres, more or less, of easement.

All iron pins set are rebar with yellow caps labeled "Claws 6456".

The bearings in this description are for angle calculations only and are based on the north line of Section 4 used as an assumed bearing of South 85°29'44" East.


