

**DEED DESCRIPTION  
FOR  
CHARLES R. READ**

Situated in Union Township, Muskingum County, Ohio and being 22.094 acres more or less in the Northwest Quarter of Section # 8, Township # 1 North, Range # 5 west in the United States Military Lands Survey and being more particularly described as follows:

Commencing at an iron pin found at the Northwest corner of the Northeast Quarter of Section # 8, Thence with the west line of the Northeast Quarter of Section 8 S 01° 00' 00" W a distance of 249.12 feet to a survey angle point at the Northeast corner of the Northwest Quarter of Section 8 the **BEGINNING**, Thence with the east line of the Northwest Quarter of Section 8 and the lands of now or formerly Walter & Leona Smith as found in Volume 1882 Page 591 S 01° 00' 00" W a distance of 1054.35 feet to a survey angle point in the center of TR. 692 ( Norwich Drive ) passing an iron pin found at 957.27 feet, Thence with said centerline and the lands of now or formerly D. W. Jordan as found in Volume 1032 Page 76 S 79° 42' 39" W a distance of 79.25 feet to a survey angle point, Thence continuing with said centerline and with the lands of now or formerly Larry & Brian James & Dirk & Jennifer James as found in Volume 1847 Page 569 the following five ( 5 ) calls:

- 1.) S 79° 27' 37" W a distance of 278.58 feet to a survey angle point.
- 2.) S 84° 54' 16" W a distance of 79.99 feet to a survey angle point.
- 3.) N 88° 52' 24" W a distance of 93.66 feet to a survey angle point.
- 4.) N 82° 27' 24" W a distance of 128.03 feet to a survey angle point.
- 5.) N 80° 32' 36" W a distance of 48.49 feet to a survey angle point, Thence leaving said road and with the lands of now or formerly Bradley Adams as found in Volume 2240 Page 159 and the lands of now or formerly Scott & Kelly Taylor as found in Volume 2241 Page 139 N 07° 33' 07" W a distance of 1126.57 feet to an iron pin found on the north line of the Northwest Quarter of Section 8 (passing iron pins found at 41.75 feet and 218.26 feet ), Thence with said north line and the lands of now or formerly Walter K. Chess Jr. as found in Volume 793 Page 285 S 88° 52' 32" E a distance of 866.55 feet to the beginning and passing an iron pin found at a distance of 864.00 feet and containing 22.094 acres more or less and being all the property conveyed to Charles R. Read as found in Volume 2234 Page 914


Bearings are assumed and are for angle calculations only and are based on the west line of the northeast quarter of Section # 8 and used as S01° 00' 00"W.




