- 4.) North 26 degrees 00 minutes 56 seconds West, 346.11 feet to an iron pin found on the south line of Meadow Estates Drive, a private drive;

Thence along the south line of said drive the following four courses:

- North 59 degrees 45 minutes 50 seconds East, 430.50 feet to an iron pin found;
- 2.) Along a curve to the right having a delta angle of 24 degrees 48 minutes 38 seconds, a radius of 454.42 feet, an arc length of 196.78 feet, and a chord which bears North 72 degrees 17 minutes 12 seconds East, 195.24 feet to an iron pin set;
- 3.) North 84 degrees 48 minutes 31 seconds East, 54.57 feet to an iron pin set;
- 4.) Along a curve to the left having a delta angle of 8 degrees 00 minutes 21 seconds, a radius of 1702.18 feet, an arc length of 237.84 feet, and a chord which bears North 82 degrees 09 minutes 16 seconds East, 237.65 feet to an iron pin found on the north line of lands presently owned by Dana L. and Holly A. Lake, (OR 1885-855);

Thence along the north line of said Lake lands the following two courses:

- 1.) South 58 degrees 14 minutes 43 seconds West, 136.80 feet to an iron pin found;
- South 83 degrees 09 minutes 43 seconds West, 103.41 feet to an iron pin found on the northwest corner of said Lake lands;

Thence along the west line of said Lake lands, South 34 degrees 17 minutes 37 seconds East, 469.85 feet to an iron pin found on the northwest corner of lands presently owned by William Kirk, and Sarah Ann Mann, (OR 2738-330);

Thence along the west line of said Kirk and Mann lands, South 37 degrees 47 minutes 15 seconds East, 199.42 feet to the principal place of beginning, containing 11.17 acres, more or less, and being all of Auditor's Parcel Number 66-14-01-07-000.
