Description For Conveyance

Situated in the State of Ohio, County of Muskingum, Township of Union in the Village of Norwich.

Being a part of the Southwest Quarter of Section 7, Quarter Township 2, Township 1, Range 5 bounded and described as follows:

Commencing at an iron pin at the most southerly corner of Lot 15 of Workman's Addition to the Village of Norwich as recorded in Deed Book I, Page 518 and also as shown on the Annexation Plat of the Village of Norwich as recorded in Plat Book 9, Pages 57 and 58; thence south 40 degrees east 13 feet to an iron pin; thence south 50 degrees west 20 feet to a point in the center of Sundale Road (Old County Road #105); thence along said road on a curve to the right having a radius of 1713.50 feet an arc distance of 382.09 feet (the chord of which bears south 33 degrees 36 minutes east 381.30 feet) to a point; thence continuing along said road south 27 degrees 12 minutes east 118.74 feet to the true place of beginning of the premises herein intended to be described; thence continuing along said road south 27 degrees 12 minutes east 80 feet to a point; thence leaving said road south 57 degrees 32 minutes 12 seconds west 299.24 feet to an iron pin; thence north 35 degrees 53 minutes west 79.78 feet to an iron pin; thence north 57 degrees 31 minutes 56 seconds east 311.33 feet to the true place of beginning, containing fifty-six hundredths (0.56) of an acre more or less.


