Being part of the Northwest Quarter, of Section #2, Township #1, Range #5, of the US Military District, being part of the prior deed reference Volume 631, Page 79 of said county's deed records, also being part of Muskingum County Auditor's Parcel Number 66-66-20-02-36-000, and more particularly described as follows;

Commencing at a stone (found with a X) at the Center of said Section #2; thence N 87 59 55 W 942.53 feet along the South line of said Northwest Quarter as described in the prior deed reference Volume 631, Page 79 to the center of Township Road #187 (Maple Brook Road) as described in said prior deed reference; thence N 05 32 26 E 370.79 feet (by deed) along a line of said prior deed reference to a point in the center of said road; thence N 12 30 58 W 139.88 feet (by deed) along a line of said prior deed reference to a point in the center of said road; thence N 41 53 41 W 173.48 feet (by deed) along a line of said prior deed reference to a point in the center of said road; thence N 50 13 15 W 150.35 feet (by deed) along a line of said prior deed reference to a point in the center of said road, also being the place of beginning for the property herein intended to be described;

- #1- thence N 50 13 15 W 24.24 feet along a line of said prior deed reference to a point in the center of said road;
- #2- thence N 30 17 48 W 180.70 feet along a line of said prior deed reference to a point within the road bed of said road;
- #3- thence N 74 10 02 E 186.46 feet leaving said road and through said prior deed reference to an iron pin (set), passing an iron pin (set) at 15.08 feet;
- #4- thence S 29 47 36 E 158.22 feet continuing through said prior deed reference to an iron pin (set);
- #5- thence S 60 08 15 W 170.91 feet continuing through said prior deed reference to the place of beginning, passing an iron pin (set) at 144.38 feet, containing 0.745 acres.


