

DEED DESCRIPTION FOR JEAN WAGGONER

Situated in Union Township, Muskingum County, Ohio and being 1.418 acres more or less in the Northeast Quarter of Section # 11 and 0.466 acres in the Southeast Quarter of Section # 10, in Township # 1 North, Range # 5 West in the United States Military Lands Survey and being more particularly described as follows:

Commencing at an iron pin found at the Northwest corner of the Northeast Quarter of Section # 11, Thence with the north line of the Northeast Quarter of Section # 11 S 89° 32' 13" E a distance of 1285.11 feet to a point, Thence S 44° 53' 03" E a distance of 18.38 feet to an iron pin set the BEGINNING, Thence with a new division line through the lands of now or formerly Jean Waggoner as found in Volume 1660 Page 222 N 59° 06' 34" E a distance of 281.83 feet to an iron pin set, Thence with the lands of now or formerly Pauline Ferguson as found in Volume 1819 Page 502 the following two (2) calls:

1. S 31° 43' 49" E a distance of 283.99 feet to an iron pin found.
2. S 28° 17' 36" E a distance of 60.05 feet to an iron pin found, Thence with the lands of now or formerly Stanley Archer as found in Volume 1068 Page 382 S 61° 41' 13" W a distance of 200.00 feet to an iron pin found, Thence with the lands of now or formerly Jean Waggoner as found in Volume 1775 Page 275 N 44° 53' 03" W a distance of 345.20 feet to the beginning and containing 1.884 acres more or less and being a part of the property conveyed to Jean Waggoner as found in Volume 1660 Page 222.


