Commencing at the intersection of the center line of Westview Drive and Highland Avenue; thence South $0^{\circ} 22' 00''$ West along center of Highland Avenue 372.79 feet to a point; thence leaving center line of Highland Avenue North $89^{\circ} 38' 00''$ West 29.59 feet to an iron pin found, the place of beginning; thence South $0^{\circ} 22' 00''$ West along Highland Avenue 99.86 feet to an iron pin; thence South $74^{\circ} 26' 35''$ West along James M. & Patricia S. Taylor 267.69 feet to an iron pin found; thence North $16^{\circ} 08' 44''$ West 99.68 feet to an iron pin found; thence North $75^{\circ} 08' 53''$ East along second tract of John E. & Norma J. Lorenz 296.13 feet to the place of beginning, containing 0.634 acres more or less.

Tract Two:

Being part of Lot No. 12 Earl Johnson Subdivision No. 2, described as follows:

Beginning at an iron pin found at the Northeast corner of above described Tract One; thence South $75^{\circ} 08' 53''$ West along the North line of tract one 296.13 feet to an iron pin found; thence North $72^{\circ} 56' 12''$ East along the South line of Dorothy Devine 219.12 feet to an iron pin set; thence along Dorothy Devine North $81^{\circ} 24' 00''$ East 77.64 feet to the place of beginning, containing 0.029 acres more or less.

Bearings are based on the center of Highland Avenue (concrete road center visible) bearing South $0^{\circ} 22' 00''$ West.

Iron pins set are No. 5 reinforcing bars 30 inches long with plastic I. D. caps.

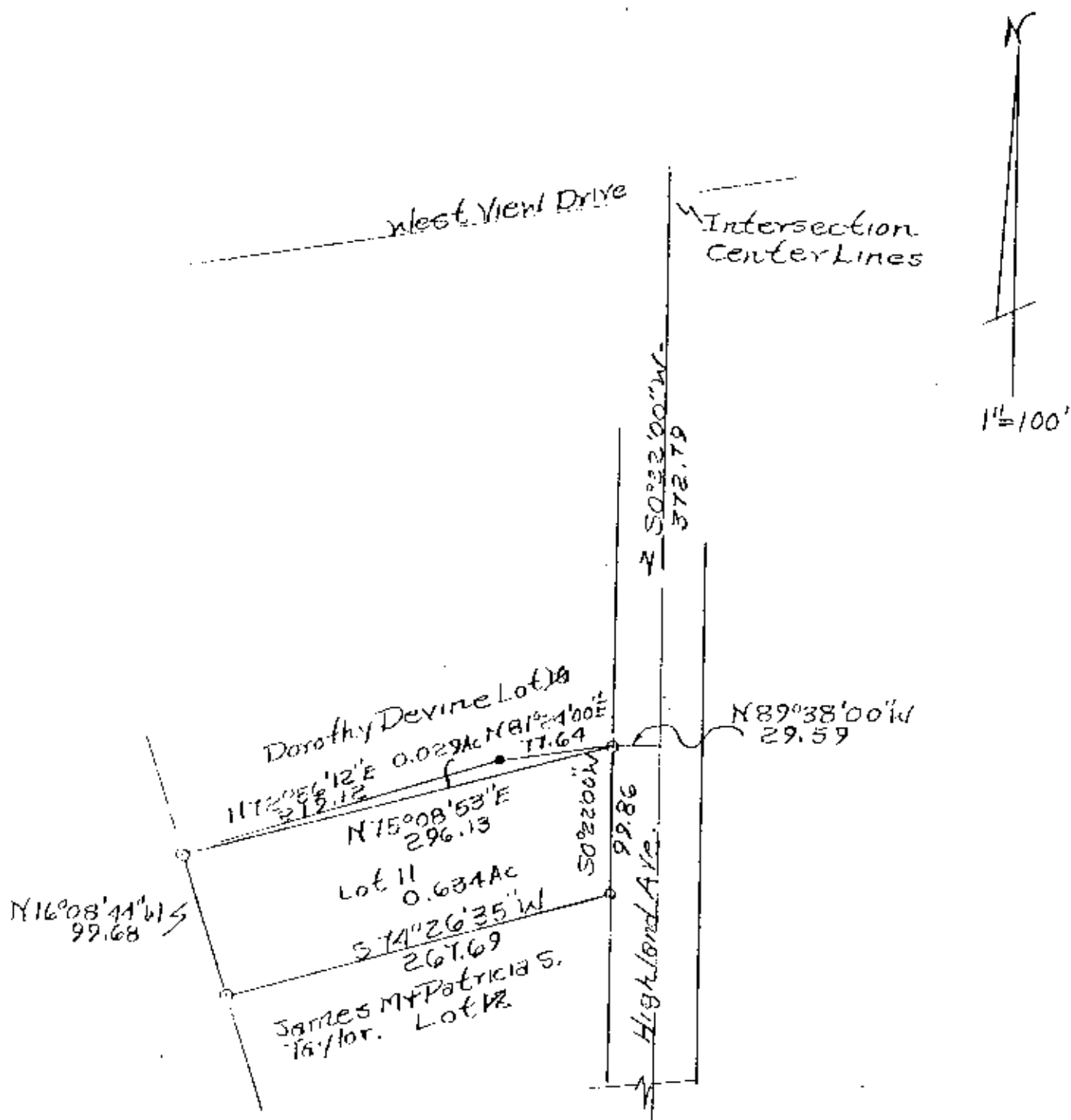
