BEING A PART OF THE SOUTHEAST QUARTER OF SECTION 2 AND THE NORTH HALF OF SECTION 9, TOWNSHIP 1, RANGE 5, OF THE UNITED STATES MILITARY LANDS, UNION TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT AN EXISTING IRON PIN (1 INCH REBAR) AT THE SOUTHWEST CORNER OF THE SOUTHEAST QUARTER OF SECTION 2;

THENCE WITH THE WEST LINE OF THE SAID SOUTHEAST QUARTER, NORTH 01 DEGREES 21 MINUTES 20 SECONDS WEST 518.34 FEET TO A POINT IN TOWNSHIP ROAD 187 (MAPLE BROOK ROAD);

THENCE LEAVING THE SAID WEST LINE AND TRAVERSING THROUGH THE H. AND P. BRADFORD TRACT (DEED VOLUME 823, PAGE 96), NORTH 86 DEGREES 56 MINUTES 00 SECONDS EAST 378.96 FEET TO AN IRON PIN SET ON THE WESTERLY LINE OF T. TEAGARDEN TRACT (DEED VOLUME 78A, PAGE 52), PASSING AN IRON PIN SET AT 23.37 FEET;

THENCE WITH THE SAID TEAGARDEN WESTERLY LINES THE NEXT THREE COURSES AND DISTANCES:

- 1) SOUTH 23 DEGREES 42 MINUTES 02 SECONDS EAST 41.59 FEET TO AN IRON PIN SET;
- 2) SOUTH 61 DEGREES 33 MINUTES 23 SECONDS EAST 105.88 FEET TO AN IRON PIN SET;
- 3) SOUTH 18 DEGREES 36 MINUTES 38 SECONDS EAST 359.98 FEET TO A POINT ON THE NORTH RIGHT-OF-WAY LINE OF THE B. AND O. RAIL ROAD (SOUTH RIGHT-OF-WAY LINE U. S. RT. 40), PASSING AN EXISTING IRON PIN AT 182.00 FEET;

THENCE WITH THE SAID RIGHT-OF-WAY LINE, SOUTH 74 DEGREES 40 MINUTES 05 SECONDS WEST 1516.37 FEET TO A POINT;

THENCE LEAVING THE SAID RIGHT-OF-WAY LINE NORTH 02 DEGREES 28 MINUTES 49 SECONDS WEST 279.04 FEET TO A POINT AT THE SOUTHWEST CORNER OF LOT 3 OF TAVENNER FARMS SUBDIVISION (PLAT BOOK 15, PAGE 8-10);

THENCE WITH THE SOUTH LINE OF SAID LOTS 3 AND 2, NORTH 89 DEGREES 14 MINUTES 31 SECONDS EAST 420.66 FEET TO A POINT;


