Situated in the Village of new Concord, in the County of Muskingum, and the State of Ohio:

Being Lots Numbered Fifty-one (51), Fifty-two (52), and Fifty-three (53) of Lincoln Place Addition to the Village of New Concord, according to an unrecorded plat thereof, and being more particularly described as follows:

Commencing, for reference, at the Southwest corner of Lot Numbered Fifty-four (54) of Lincoln Place Addition to the Village of New Concord as Recorded in Plat Book Five (5), Page Nineteen (19), of the Muskingum County Records; thence run South 05 degrees 06 minutes 38 seconds East across Harper Street (aka Harper Avenue) a distance of 60.06 feet to an iron pin (rebar) set at the Northwest corner of the aforesaid Lot Fifty-three (53), and being the Place of Beginning of the premises herein intended to be described; thence North 87 degrees 30 minutes 00 seconds East along the Southerly line of Harper Street a distance of 132.00 feet to an iron pin (rebar) set; thence South 01 degree 30 minutes 00 seconds East a distance of 150.00 feet to an iron pin (rebar) set on the Northerly line of an alley; thence South 87 degrees 30 minutes 00 seconds West along the Northerly line of said alley a distance of 122.54 feet to an iron pin (rebar) set on the Easterly line of an alley at the west side of said Addition; thence North 05 degrees 06 minutes 38 seconds West along the Easterly line of said alley a distance of 150.13 feet to the Place of Beginning, containing 0.438 Acre, more or less, and being a new survey of those premises conveyed to Mike L. Whiteman and Gina M. Whiteman as described in Book 961, Page 17 et seq., of the Deed Records of said County.
