**DESCRIPTION FOR ALLEY VACATION**

Situated in the State of Ohio, County of Muskingum, Village of New Concord, and being all that portion of a 16.5 foot wide alley that lies north of the east half of Lot 60 and North of all of Lots 58, 56, 54 and 52 of the College Addition to New Concord, as recorded in Deed Volume "U", page 655; being further bounded and described as follows:

**Beginning** at the northeast corner of Lot 52 of said College Addition, thence, along the south line of said 16.5 foot alley and the north line of Lot 52, now or formerly owned by New Concord Methodist Church (464/528), thence, south 85 degrees – 37 minutes – 38 seconds west, 66.66 feet to a point at the northeast corner of Lot 54;

**Thence**, continuing along the north line of said New Concord Methodist Church, the following two (2) courses and distances:

1. South 85 degrees – 37 minutes – 38 seconds west, 66.66 feet to a point at the northeast corner of Lot 56;
2. South 85 degrees – 37 minutes – 38 seconds west, 66.66 feet to a point at the northwest corner of said Lot 56;

**Thence**, continuing along the south line of aforesaid alley, south 85 degrees – 37 minutes – 38 seconds west, 17.16 feet to a point at the northeast corner of Lot 58;

**Thence**, continuing along the north line thereof and the north line of said New Concord Methodist Church (502/651), south 85 degrees – 37 minutes – 38 seconds west, 66.66 feet to a point at the northeast corner of Lot 60;

**Thence**, along the north line thereof – also being the north line of those lands now formerly owned by Muskingum College (1761/892), south 85 degrees – 37 minutes – 38 seconds west, 33.38 feet to a point;

**Thence**, north 04 degrees – 22 minutes – 22 seconds west, crossing said alley and along the east line of those lands now or formerly owned by Muskingum College (1105/305) and (1761/892) by virtue of a previous alley vacation, 16.50 feet to a point at the southwest corner of those lands now formerly owned by New Concord Methodist Church (1616/259);

**Thence**, north 85 degrees – 37 minutes – 38 seconds east, along the north line of aforesaid alley to be vacated, 64.00 feet to a point;

**Thence**, continuing north 85 degrees – 37 minutes – 38 seconds east, 34.38 feet, along the south line of those lands now formerly owned by Muskingum College (1005/11) to a point;

**Thence**, continuing north 85 degrees – 37 minutes – 38 seconds east, 218.80 feet, along the south line of those lands last recorded Deed transferred to Otho Shipley from J. Knox Montgomery (173/545) to a point;
