Thence $N 21^{\circ} 15' W$ for 386.10 feet to a point in said road;

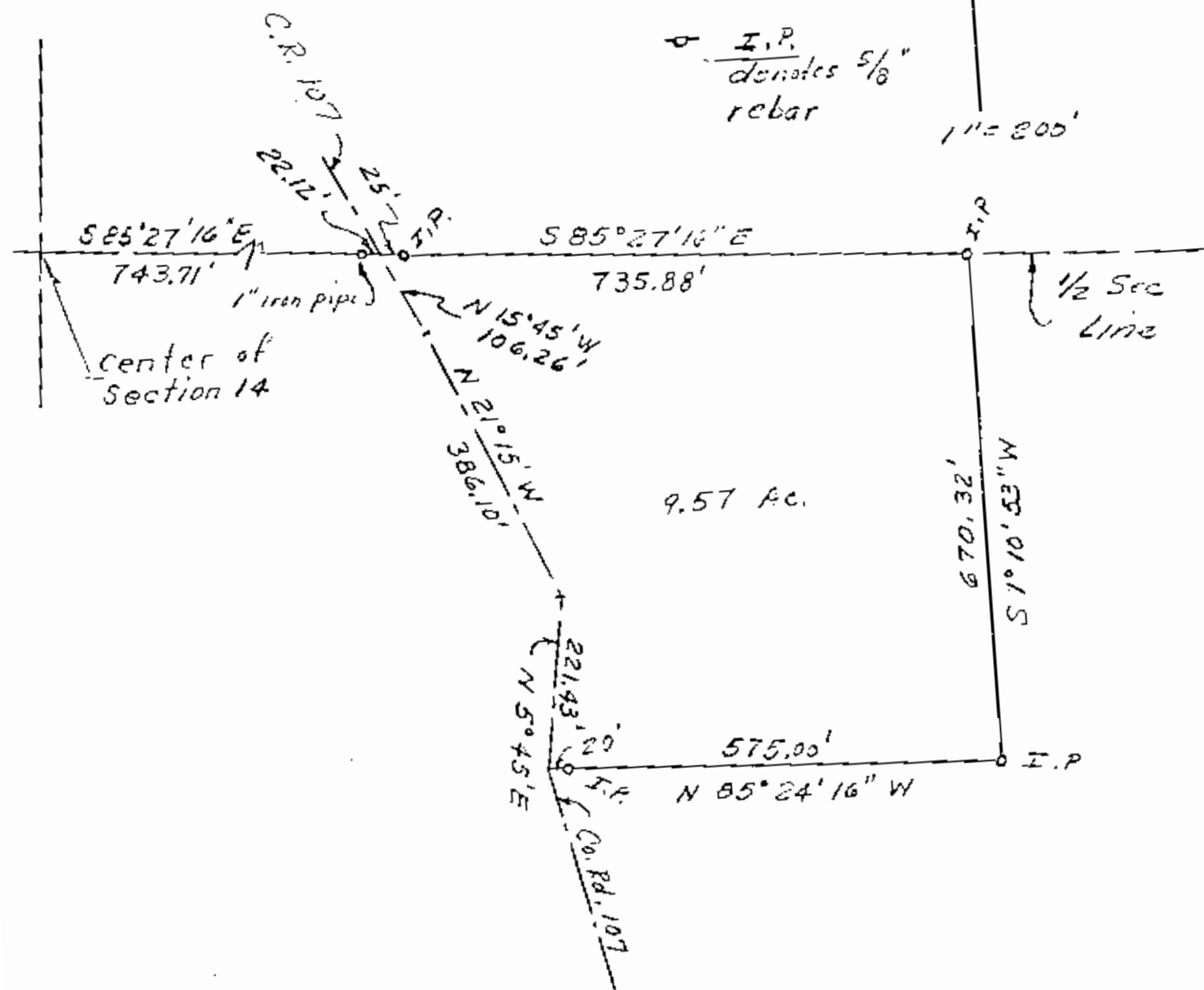
