Situated in the Township of Union, County of Muskingum and State of Ohio:

Being a part of the North Half of the Northwest Quarter of Section 25, Township 1 of Range 5, Muskingum County and being more fully described as follows:

Beginning at an iron pin found at the Northeast corner of the Northwest Quarter of Section 25;

Thence S 5° 00' 00" W along the East line of the Northwest Quarter of Section 25, a distance of 506.79 feet to an iron pin set, said point being the True Place of Beginning;

Thence continuing S 5° 00' 00" W along the West line of lands now or formerly owned by G. & K. James (758/51), a distance of 800.00 feet to an iron pin found;

Thence N 85° 04' 00" W along the North line of lands now or formerly owned by E. White (786/245), a distance of 1222.00 feet to an iron pin set;

Thence N 5° 00' 00" E along lands now or formerly owned by E. White, a distance of 800.00 feet to an iron pin set;

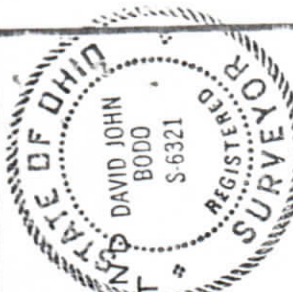
