

DESCRIPTION OF SURVEY FOR DAVE NOEL ET AL

Being part of the Southwest Quarter of Fractional Section #18, also being part of the West Half of Military Lot #15, and part of Military Lot #16, of Quarter Township #4, Township #1, Range #5, of the US Military District, further being part of the Eugene Noel property recorded in Deed Book Volume 1081, Page 211, and more particularly described as follows:



- #37- **THENCE North 02 degrees 30 minutes 00 seconds East 208.61 feet** along the common line for said Military Lot #16 and Fractional Section #18, to the place of beginning, containing **0.79 acres** from the Southwest Quarter of Section #18, further being part of Muskingum County **Auditor's Parcel Number 66-80-18-04-000**, and **17.78 acres** from said Military Lot #15, further being part of Muskingum County **Auditor's Parcel Number 66-80-04-05-000**, and **32.19 acres** from said Military Lot #16, further being part of Muskingum County **Auditor's Parcel Number 66-80-04-07-000**, for a total of **50.76 acres**.

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1993) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).


