DESCRIPTION 5.200 ACRE TRACT - TRACT 31B

Being situated in the southeast quarter of Section seventeen (17), Township one (1) North, Range five (5) West, Union Township, Muskingum County, State of Ohio and being part of that land conveyed to Sidney L. Hurdle record in Deed Volume 1079 Page 133 in the Muskingum County Recorder's Office; being part of Muskingum County Auditor's Parcel # 66-66-80-17-17-~~000~~⁰¹², and being more particularly described as follows;

Beginning for reference at a 3/4 inch iron pipe found at the northwest corner of the southeast quarter of Section 17; thence South 02 degrees 30 minutes 32 seconds West along the mid-section line a distance of 619.32 feet to a 3/4 inch iron pipe set and being the true place of beginning;

thence from the place of beginning North 76 degrees 39 minutes 36 seconds East a distance of 1031.81 feet (passing over a 3/4 inch iron pipe found at 1001.81 feet) to a point in South Cove Lane (Township Road 367);

thence South 14 degrees 37 minutes 46 seconds East along the centerline of South Cove Lane a distance of 212.86 feet to a point;

thence South 76 degrees 39 minutes 36 seconds West a distance of 1097.01 feet (passing over a 3/4 inch iron pipe set at 30.00 feet) to a 3/4 inch iron pipe set;

thence North 02 degrees 30 minutes 32 seconds East along the mid-section line, the easterly boundary of J. Evans (D.V. 1051 P. 518), a distance of 221.21 feet to the place of beginning - containing 5.200 acres, more or less.

Subject to all legal right-of-way of previous record.

The above description was prepared from a survey made by me, Samuel W. Vance, Registered Surveyor No. 6553 in November, 1995. Bearing basis assumed.


