Situated in the State of Ohio, County of Muskingum, Township of Union, being part of Lot 7 of Quarter Township Four, Township 1 North, Range 5 West, of the United States Military Lands, and further described as follows:

Beginning at a stone found at the Southwest corner of Lot 7,

thence; along the west line of Lot 7 North 00 degrees 52 minutes 51 seconds West 478.60 feet to an iron pin found,

thence; North 44 degrees 47 minutes 01 seconds East 670.58 feet to an iron pin found,

thence; continuing North 44 degrees 47 minutes 01 seconds East 260.59 feet to an iron pin found,

thence; North 41 degrees 38 minutes 00 seconds East 348.93 feet to an iron pin found,

thence; continuing North 41 degrees 38 minutes 00 seconds East 32.38 feet to a point in the center of Rix Mills Road (CR 5),

thence; along the centerline of Rix Mills Road the following two (2) courses,

1. North 64 degrees 17 minutes 11 seconds West 56.85 feet to a point, and
2. North 62 degrees 46 minutes 58 seconds West 58.16 feet to a point, said point being the true point of beginning,

thence; along the center line of Rix Mills Road, North 63 degrees 50 minutes 25 seconds West 242.01 feet to a point at the intersection of Rix Mills Road and Patton Lane (TR 201),

thence; along Patton Lane, North 67 degrees 21 minutes 55 seconds East 375.99 feet to a point in Patton Lane,

thence; leaving Patton Lane and through the lands of Robert Eugene, & Loreita Jean Slack, Deedbook 1903, Page 88, South 22 degrees 38 minutes 05 seconds East 15.00 feet to an iron pin set,

thence; continuing through the lands of Robert Eugene, & Loreita Jean Slack, South 26 degrees 24 minutes 52 seconds East 76.17 feet to an iron pin set,

thence; continuing through the lands of Robert Eugene, & Loreita Jean Slack, South 45 degrees 01 minutes 18 seconds West 239.57 feet to the true point of beginning passing an iron pin set at 207.87', containing 1.02 acres, more or less.

Subject to all easements, right of ways, restrictions, and reservations of record and those that may be implied.
