

## DESCRIPTION OF SURVEY FOR SCOTT TAYLOR

Situated in the State of Ohio, County of Muskingum, Township of Union:

Being part of the Lot #18, Township #1, Range #5 of the US Military District, being part of the Kansas State University property as described in Tract Eight of deed reference Deed Book Volume 1083, Page 641 of said county's deed records, and known as Muskingum County Auditor's Parcel Number 66-90-04-45-000 and more particularly described as follows;


Commencing at an iron pipe (found) at the Southwest corner of said Lot #18 also being the common corner for Lots #17 #23, & #24 of said Township and Range; thence N 02 25 40 E 1311.22 feet along the common line for said Lots #17 and #18 to an iron pin (set), being the place of beginning for the property herein intended to be described, passing the center line of Rix Mills Road (County Road #55) at 779.48 feet;

- #1- thence N 02 25 40 E 126.91 feet continuing along said common line for Lots #17 & #18 to an iron pin (found) at the common corner for said Kansas State University property, for the D & C Cubbison property recorded in deed reference Deed Book Volume 1086, Page 316, and for a remaining portion of the Wilma Cubbison property recorded in deed reference Deed Book Volume 858, Page 57;
- #2- thence S 87 34 20 E 84.00 feet into said Lot #18 and along a common line for said Kansas State University and D & C Cubbison properties to an iron pin (found) at a common corner for said Kansas State University and D & C Cubbison properties;
- #3- thence S 02 25 40 W 121.04 feet through said Kansas State University property to an iron pin (set);
- #4- thence S 88 25 50 W 84.20 feet continuing through said Kansas State University property to the place of beginning containing 0.24 acres.

The bearings within the description are based on State Plane Coordinate Grid derived from an average of numerous Solar Observation (Local Hour Angle Method). Observations were calculated with a range of + or - 27 seconds. Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).


