STOTTS TRACT (VOLUME 1131, PAGE 702), TO AN EXISTING IRON PIN (3/4 INCH PIPE) AT THE SOUTHWEST CORNER OF A TRACT CONVEYED BY DEED TO W. T. MURPHY AS RECORDED IN VOLUME 1131, PAGE 704 OF THE MUSKINGUM COUNTY DEED RECORDS; THENCE NORTH 04 DEGREES 54 MINUTES 00 SECONDS EAST 265.83 FEET, ALONG THE WEST LINE OF THE SAID MURPHY TRACT, TO AN EXISTING IRON PIN (3/4 INCH ID PIPE) ON THE SOUTH LINE OF A 2.70 MORE OR LESS ACRE TRACT CONVEYED BY DEED TO ROSE E. STOTTS AS RECORDED IN VOLUME 1052, PAGE 293 OF THE SAID COUNTY RECORDS; THENCE WITH THE SAID SOUTH LINE, NORTH 86 DEGREES 58 MINUTES 00 SECONDS WEST 133.02 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR); THENCE WITH THE WEST LINE OF THE SAID 2.70 MORE OR LESS ACRE TRACT, NORTH 04 DEGREES 22 MINUTES 41 SECONDS EAST 487.10 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR), SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED; THENCE NORTH 86 DEGREES 58 MINUTES 00 SECONDS WEST 62.22 FEET TO AN IRON PIN SET; THENCE NORTH 04 DEGREES 22 MINUTES 41 SECONDS EAST 130.26 FEET TO AN IRON PIN SET ON THE SOUTH LINE OF A 5.00 MORE OR LESS ACRE TRACT CONVEYED TO M. AND T. 
