THENCE SOUTH 88 DEGREES 09 MINUTES 53 SECONDS EAST 384.87 FEET ALONG THE NORTH LINE OF SARAH TROTT PROPERTY TO AN IRON PIN SET,

THENCE LEAVING SAID NORTH LINE SOUTH 01 DEGREES 50 MINUTES 07 SECONDS WEST 558.40 FEET TO A POINT IN THE CENTER OF TOWNSHIP ROAD 190 (CULBERTSON ROAD) PASSING AN IRON PIN SET AT 508.40 FEET;

THENCE NORTH 84 DEGREES 26 MINUTES 02 SECONDS WEST 37.25 FEET TO A POINT IN THE CENTER OF THE SAID ROAD;

THENCE NORTH 87 DEGREES 01 MINUTES 32 SECONDS WEST 167.44 FEET TO A POINT IN THE CENTER OF SAID ROAD;
