

DESCRIPTION

Situated in the Township of Washington, County of Muskingum, State of Ohio, and bounded and described as follows:

Being a part of Lot 5 and Lot 6 of Underwood's Subdivision as delineated in Muskingum County Deed Book "E", Page 62, Township 1 North, Range 7 West, United States Military Lands, Washington Township, Muskingum County, Ohio and a part of the property of Zanesville-Muskingum County Port Authority as described in Volume 1142, Page 426 of the Muskingum County Records and more particularly described as follows:

Beginning for reference at an iron pin found (Finley 7222) at the northeast corner of Lot 6; thence South 33 degrees 27 minutes 50 seconds West, 198.96 feet to an iron pin set and the principal place of beginning of the tract to be conveyed; thence 728.54 feet on a curve to the left with a radius of 970.00 feet, a delta angle of 43 degrees 01 minute 59 seconds and a chord of which bears South 27 degrees 20 minutes 30 seconds West, 711.53 feet to an iron pin set; thence South 05 degrees 49 minutes 31 seconds West, 449.44 feet to an iron pin set; thence South 03 degrees 59 minutes 59 seconds West, 371.35 feet to an iron pin set; thence South 02 degrees 40 minutes 24 seconds West, 320.69 feet to an iron pin set; thence South 01 degree 44 minutes 46 seconds West, 170.42 feet to an iron pin set, passing the lot line between lot 6 and lot 5 at 126.58 feet; thence 138.87 feet on a curve to the right with a radius of 430.00 feet, a delta angle of 18 degrees 30 minutes 13 seconds and a chord of which bears South 10 degrees 59 minutes 53 seconds West, 138.27 feet to an iron pin set; thence North 86 degrees 30 minutes 21 seconds West, 1418.98 feet to an iron pin set; thence North 03 degrees 26 minutes 36 seconds East (being the basis of bearings for this description), 2061.49 feet to an iron pin set, passing the lot line between lot 5 and lot 6 at 154.49 feet, thence South 87 degrees 45 seconds 03 seconds East, 1738.72 feet to the place of beginning. The tract as surveyed contains 70.00 acres, more or less, (5.52 acres in Lot 5 (being a part of parcel # 70-13-02-30) and 64.48 acres in Lot 6 (being a part of parcel # 70-13-02-06)) subject to all legal highways and easements of record.

Including with the above described tract is a strip easement 70 foot wide for ingress / egress along the entire eastern line of the above described tract for access to Bateman Road.

Iron pins set are 3/4 inch rebar, 30 inches long set flush with the ground with plastic caps # 6651.




