- TIE-2 THENCE South 03 degrees 09 minutes 48 seconds West 74.98 feet continuing along said Lot and Half Quarter Section line and crossing said Michel property to an iron pin (found capped 7113) at a corner of the Renee Lynn Pieper property recorded in Official Record Volume 2873, Page 606;
- TIE-3 THENCE South 86 degrees 25 minutes 08 seconds East 595.54 feet into Lot 3 and along the common line for said Michel and Pieper properties to an iron pin (found capped 7113) at a corner of said Green property and place of beginning for the property herein intended to be described;
- #1- THENCE North 03 degrees 05 minutes 00 seconds East 305.91 feet along a common line for said Green and Michel properties to an iron pin (found capped 7113);
- **#2- THENCE North 81 degrees 22 minutes 29 seconds East 62.89 feet** continuing along said properties to an unmarked point in the centerline of Church Hill Road, passing an iron pin (found capped 7113) at 31.87 feet;
