

DESCRIPTION OF SURVEY FOR TIM RASOR

JOB#1369-2

Situated in the State of Ohio, County of Muskingum, Township of Washington:

Being part of the Southeast Quarter, of Section #9, Township #1, Range #7, of the, US Military District, being part of the T Rasor property recorded in Deed Book Volume 1144, Page 790 of said county's deed records, further being known as Muskingum County Auditor's Parcel Number 70-15-09-33-001, and more particularly described as follows;

Beginning at an iron pin (found) at the common corner for the Southwest and Southeast Quarters of Section #9 and for the Northeast and Northwest Quarters of Section #12 of said Township and Range; **THENCE South 86 degrees 51 minutes 45 seconds East 1010.91 feet** along the common line for said Sections #9 and #12 to an unmarked point in the centerline of Adamsville Road (State Route #93); **THENCE along a curve to the right having a chord bearing North 09 degrees 35 minutes 20 seconds East 200.98 feet**, a radius of 1295.41 feet, and arc length of 201.18 feet, into said Southeast Quarter of Section #9 and along the centerline of said road to an unmarked point; **THENCE along a curve to the right having, a chord bearing North 16 degrees 22 minutes 10 seconds East 167.98 feet**, a radius of 2064.91 feet, and arc length of 168.03 feet, continuing along said road to an unmarked point; **THENCE North 18 degrees 42 minutes 00 seconds East 486.39 feet** continuing along said road centerline to the unmarked common corner for said T Rasor property and for the R & B Schley property recorded in Deed Book Volume 1149, Page 743, **THENCE North 18 degrees 12 minutes 25 seconds East 92.16 feet** along said road centerline as surveyed by Dana Snouffer PLS #7543 dated October 1997 to an unmarked point; **THENCE North 25 degrees 51 minutes 40 seconds East 73.28 feet** continuing along said road center and Snouffer survey to an unmarked point; **THENCE North 31 degrees 12 minutes 40 seconds East 46.00 feet** continuing along said road center and Snouffer survey to an unmarked point; **THENCE North 39 degrees 56 minutes 40 seconds East 46.38 feet** continuing along said road center and Snouffer survey to an unmarked point; **THENCE North 46 degrees 33 minutes 40 seconds East 44.89 feet** continuing along said road center and Snouffer survey to an unmarked point, being the place of beginning for the property herein intended to be described;

- #1- **THENCE North 58 degrees 38 minutes 40 seconds East 75.40 feet** continuing along said road center and Snouffer survey to an unmarked point;
- #2- **THENCE North 75 degrees 27 minutes 10 seconds East 186.80 feet** continuing along said road center and Snouffer survey to an unmarked point;
- #3- **THENCE North 82 degrees 02 minutes 20 seconds East 255.04 feet** continuing along said road center and Snouffer survey to the unmarked Northeast Corner of said T Rasor property also being a corner of the J Rasor property recorded in Deed Book Volume 1121, Page 163;
- #4- **THENCE South 03 degrees 09 minutes 15 seconds West 416.64 feet** leaving said road and along the common line for said T Rasor and J Rasor properties to an iron pin (found) at a common corner for said T Rasor, J Rasor, and Schley properties, passing an iron pin (found) at 32.73 feet;
- #5- **THENCE North 88 degrees 45 minutes 15 seconds West 180.90 feet** along the common line for said T Rasor and Schley properties to an iron pin (set);
- #6- **THENCE North 18 degrees 40 minutes 40 seconds East 134.84 feet** though said T Rasor property to an iron pin (set);
- #7- **THENCE North 65 degrees 06 minutes 45 seconds West 371.97 feet** continuing through said T Rasor property to the place of beginning, passing an iron pin (set) at 336.97 feet **containing 2.52 acres.**

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).
