Bednarczuk Volume 995, page 56, South 87°23'40" East 1053.36 feet to an iron pin set passing an iron pin found at 53.63 feet; Thence along the split lines of Robert P. Norris Volume 1141, page 391, South 4°06'21" West 173.08 feet to an iron pin; Thence North 87°23'40" West 1047.02 feet along P. Murray O.R. 1553, page 201, to a corner post; Thence North 02°02'11" East along P. Murray 173.00 feet to the place of beginning containing 4.17 Acres more or less.

Bearings are based on the West line of Section 10 bearing South 02°24'50" West.

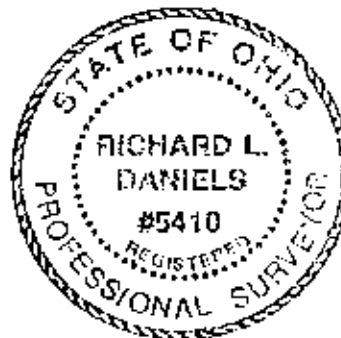
