- 2) SOUTH 84 DEGREES 42 MINUTES 00 SECONDS EAST 190.74 FEET TO THE PLACE OF BEGINNING, PASSING AN IRON PIN SET AT 160.74.

COMMENCING AT THE NORTHEAST CORNER OF THE SOUTHWEST QUARTER OF SAID SECTION 10:

THENCE SOUTH 05 DEGREES 18 MINUTES 00 SECONDS WEST 462.60 FEET (BY DEED) TO A POINT IN THE CENTER OF COUNTY ROAD 191 (JACKSON ROAD);

THENCE SOUTH 05 DEGREES 18 MINUTES 00 SECONDS WEST 282.50 FEET TO A POINT IN THE SAID ROAD, SAID POINT BEING THE PLACE OF BEGINNING OF THIS EASEMENT;

THENCE CONTINUING SOUTH 05 DEGREES 18 MINUTES 00 SECONDS WEST 10.00 FEET TO A POINT IN THE SAID ROAD;

THENCE LEAVING THE SAID ROAD AND TRAVERSING INTO THE SAID WATIKER TRACT THE NEXT THREE COURSES AND DISTANCES:

- 1) NORTH 83 DEGREES 58 MINUTES 37 SECONDS WEST 61.84 FEET TO A POINT;
- 2) NORTH 76 DEGREES 10 MINUTES 53 SECONDS WEST 62.17 FEET TO A POINT;
- 3) SOUTH 84 DEGREES 42 MINUTES 00 SECONDS EAST 123.32 FEET TO THE PLACE OF BEGINNING, PASSING AN IRON PIN SET AT 73.40 FEET.
