thence along the south line of said Howard's land, South 87 degrees 08 minutes 54 seconds East 215.18 feet to an iron pin found on the southwest corner of lands now owned by Mark E. Green (OR 2804-60);

thence along the south line of said Green's land, South 87 degrees 08 minutes 54 seconds East 490.38 feet to an iron pin found on the southwest corner of lands now owned by Marilyn J. Howard and Mark E. Green (OR 1994-0072), from which an iron pin found bears North 02 degrees 50 minutes 56 seconds East a distance of 262.75 feet;

thence along the south line of said Howard and Green's land, South 87 degrees 08 minutes 54 seconds East 449.29 feet to the centerline of Jackson Road (CR-191), passing an iron pin found at 419.29 feet;

thence along said centerline of Jackson Road, South 04 degrees 52 minutes 39 seconds West 30.93 feet to the northeast corner of lands now owned by Marilyn J. Howard (OR 1994-0072);

thence along the north line of said Howard's land, North 87 degrees 08 minutes 54 seconds West 448.14 feet to an iron pin set on Howard's northwest corner, passing an iron pin found at 30.00 feet;
