VOLUME 1702, PAGE 453 OF THE MUSKINGUM COUNTY OFFICIAL RECORDS, SITUATED IN THE NORTHEAST QUARTER OF SECTION 12, TOWNSHIP 1, RANGE 7, OF THE UNITED STATES MILITARY LANDS, WASHINGTON TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHWEST CORNER OF THE NORTHEAST QUARTER OF SECTION 12;

THENCE WITH THE NORTH LINE OF THE SAID SECTION, SOUTH 86 DEGREES 52 MINUTES 26 SECONDS EAST 1557.24 FEET (DEED) TO A POINT;

THENCE LEAVING THE SAID NORTH LINE AND WITH THE EAST LINE OF A TRACT CONVEYED TO JAMES A. AND SUSAN J. McDONALD IN O.R. VOLUME 1724, PAGE 731, SOUTH 03 DEGREES 16 MINUTES 15 SECONDS WEST 1331.85 FEET (DEED) TO A POINT;

THENCE WITH THE SOUTH LINE OF THE SAID McDONALD TRACT, ALSO BEING THE NORTH LINE OF A TRACT CONVEYED TO JOHN AND DOROTHY MONTGOMERY IN DEED VOLUME 456, PAGE 16 OF THE MUSKINGUM COUNTY DEED RECORDS, NORTH 86 DEGREES 56 MINUTES 07 SECONDS WEST 318.29 FEET (DEED) TO AN EXISTING IRON PIN (AXLE), SAID IRON PIN BEING THE **PLACE OF BEGINNING** FOR THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE CONTINUING WITH THE NORTH LINE OF THE SAID MONTGOMERY TRACT AND THEN WITH THE NORTH LINE OF A TRACT CONVEYED TO MARTHA M. VOGEL IN DEED VOLUME 1139, PAGE 945, NORTH 86 DEGREES 56 MINUTES 07 SECONDS WEST 560.50 FEET TO THE CENTER OF STATE ROUTE 93 (ADAMSVILLE ROAD-1955 SURVEY), PASSING AN EXISTING IRON PIN (AXLE) AT 318.69 FEET AND EXISTING CONCRETE MONUMENTS AT 497.15 FEET AND 512.01 FEET;

THENCE WITH THE CENTER OF THE SAID ROAD, WITH A CURVE TO THE LEFT HAVING A RADIUS OF 2864.78 FEET (CHORD BEARING NORTH 32 DEGREES 11 MINUTES 52 SECONDS EAST 91.74 FEET, DELTA ANGLE 1 DEGREE 50 MINUTES 06 SECONDS) AN ARC LENGTH OF 91.75 FEET TO A POINT;

THENCE LEAVING THE SAID ROAD AND WITH THE SOUTH LINE OF THE ABOVE SAID McDONALD TRACT THE FOLLOWING TWO COURSES AND DISTANCES:

1. SOUTH 86 DEGREES 55 MINUTES 12 SECONDS EAST 515.84 FEET TO A POINT, PASSING AN EXISTING IRON PIN (AXLE) AT 60.56 FEET;
2. SOUTH 03 DEGREES 03 MINUTES 53 SECONDS WEST 80.00 FEET TO THE **PLACE OF BEGINNING**, PASSING AN EXISTING IRON PIN (AXLE) AT 0.46 FEET;

CONTAINING 0.989 ACRES, SUBJECT TO ALL LEGAL ROAD RIGHT OF WAYS OF STATE ROUTE 93 AND ALL OTHER APPLICABLE EASEMENTS.


