

Situated in the State of Ohio, County of Muskingum, Township of Washington, Quarter Township 3, Township 1, Range 7, United States Military Lands and being a part of Lot Two of Underwood's Subdivision as recorded in Deed Book "E", Page 62 of Muskingum County Records and being further described as follows:

To locate the true place of beginning of the parcel being conveyed the following information was copied from Deed Book 864, Page 95 of the Muskingum County Records:

Commencing at the Northeast corner of said Lot 2, thence West 1,116.06 feet to a point, thence North $84^{\circ} 00'$ West 1,076.00 feet along the north line of said Lot 2 to a point in the center of Fox Lane, thence South $02^{\circ} 27'$ East, 211.00 feet to a point in the center of Fox Lane, thence South $01^{\circ} 38'$ West 217.00 feet to a point in the center of Fox Lane, thence South $08^{\circ} 03'$ East 100.00 feet to a point in the center of Fox Lane, thence leaving Fox Lane, South $84^{\circ} 32'$ East 363.35 feet along the north line of B. and R. Wagner (Deed Book 570, Page 252) and the north line of P. and B. Heil (Deed Book 864, Page 94) to the northeast corner of said P. and B. Heil, thence South $7^{\circ} 28'$ West 328.73 feet along the east line of said P. and B. Heil to an existing iron pin (axle) at the point of beginning of the parcel herein being conveyed:

thence, South $84^{\circ} 16'$ East, 54.40 feet to an iron pin,
thence, South $5^{\circ} 44'$ West, 78.55 feet to a point in the center of County Road 694--Adamsville Road,
thence, North $85^{\circ} 41'$ West, 56.84 feet along the center-line of said County Road 694 to a point at the southeast corner of B. E. and P. Heil (Deed Book 864, Page 95)
thence, North $7^{\circ} 28'$ East, 79.99 feet to the point of beginning.




