LEGAL DESCRIPTION
Tract #2

Situated in the State of Ohio, County of Muskingum, Township of Washington, and being part of Lot 5 of Muskingum Mining Company, Plat Book 2, page 10 and all of Lots #5 and #6 of Bingham's Subdivision, as recorded in Plat Book 1, page 239, and being part of those lands intended to be described in Deed Volume 1132, page 610; being further bounded and described as follows:

Beginning at the northeast corner of Lot #5 of Muskingum Mining Company, said point also being in the centerline of Old Adamsville Road, thence, south 06 degrees - 21 minutes - 31 seconds west, 862.91 feet along the east line of said Lot #5 to a point on the north line of John Street, passing an iron pin set at 30.00 feet;

Thence, north 83 degrees - 43 minutes - 15 seconds west, 505.10 feet to an iron pin set at the southwest corner of Lot #6 Bingham's Subdivision, passing an iron pin found at 8.98 feet and also passing the southwest corner of Lot #5 of Muskingum Mining Company at 384.32 feet;

Thence, north 06 degrees - 00 minutes - 12 seconds east, 679.80 feet to an iron pin set at the northwest corner of Lot #5 of Bingham's Subdivision;

Thence, south 83 degrees - 51 minutes - 43 seconds east, 120.78 feet to an iron pin set at the northeast corner thereof;

Thence, south 06 degrees - 00 minutes - 11 seconds west, 154.10 feet to an iron pin set;

Thence, south 83 degrees - 38 minutes - 27 seconds east, 362.58 feet to an iron pin set;

Thence, north 06 degrees - 21 minutes - 31 seconds east, 334.59 feet to a point in the centerline of said Old Adamsville Road, passing an iron pin set at 297.46 feet;

Thence, along said road, north 89 degrees - 49 minutes - 16 seconds east, 25.16 feet to the **point of beginning**, and containing 6.736 acres more or less.

Iron pins set are 5/8" rebar with yellow identification cap (Finley S-7222).

Subject to all legal highways and easements, whether recorded or implied.


